

HURON TOWNSHIP BOARD OF TRUSTEES
MONDAY, DECEMBER 16, 2019

The Huron Township Board of Trustees met on Monday, December 16, 2019, at 3:15 PM., in the Township Office, 1820 Bogart Road, Huron, Ohio. Present was Chairman Gordon Hahn, Trustee Edward Enderle, Trustee Robert Boos, and Fiscal Officer Cathy Myers. Also attending were Building Official John Zimmerman, Administrative Assistant Tammy Boos, Road Department Superintendent Eric Boger, and Assistant Road Superintendent Dennis Meinert.

Chairman Hahn called the meeting to order and led all in attendance in the "Pledge of Allegiance".

Chairman Hahn explained that the purpose of the meeting was to adjourn into Executive Session and discuss Employee Compensation in accordance with Ohio Revised Code §121.22 (G-#1). With that, **Mr. Boos made a motion to adjourn into Executive Session to discuss Employee Compensation for 2020. Mr. Enderle seconded the motion and it passed unanimously at 3:17 PM.**

At 4:10 PM., a motion was made by Mr. Enderle to return to regular session. The motion was seconded by Mr. Boos and passed unanimously.
